## The Partnership meets regularly...

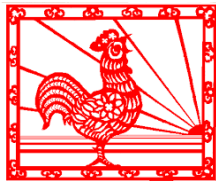
**When:** fourth Tuesday of the month with a cultural focus or current event of interest each month
